#### **EXHIBITOR DASHBOARD**

Exhibitors who have paid their booth deposit have already received login information for your exhibitor dashboard. In the dashboard you can access a copy of your contract and invoice, update your directory listing, locate housing information, access the exhibitor service kit, and more.

### **EXHIBITOR CHECKLIST**

The Exhibitor Checklist can now be found in your exhibitor dashboard. Review each item in the checklist and complete all necessary items by the due date listed.

- The checklist evolves as new deadlines and details are available. Please check back regularly.

# What is an Ancillary Event?

Any event attended by Kidney Week participants; including but not limited to those hosted by exhibitors, corporate supporters, or participants of Kidney Week; occurring in Philadelphia, PA, over the official meeting dates and/or the meeting shoulder dates; and is determined to be related to nephrology, medicine, or the pharmaceutical industry. If any combination of these conditions is met, the ASN ancillary event policy must be followed regardless of the location of the event.

Events may not be publicized until you receive approval from ASN to host your event. Please do not contact hotels directly to secure meeting space; you must receive approval to host your event before proceeding with event planning.
